Port of Munguba

- Along the Jari River, anchoring is permitted, in exceptional cases, of two vessels downstream of the town of Porto Alegre, vessels awaiting tide or daylight to sail.

- Anchoring for ships in maneuver situations (awaiting release from the pier) will also be permitted, as long as they are under favorable tide conditions (ebb tide), for ships up to 200m (LOA), above the CADAM port and between ports from JARI and CADAM, overnight stays are not permitted.

- Anchoring to await crossings with ships coming from the Port of Munguba must be avoided, only occurring in cases of extreme necessity, under the coordination of the Port Authority.

- Vessels without a schedule and others will wait at anchor in Anchoring Area No. 2, on the Amazon River (see Annex 1-B of these Rules and Procedures).

Anchorage Area – Trombetas Port

a) For ships awaiting loading, at mooring buoys 1, 2 and 3. b) For ships undergoing repair, quarantine, awaiting weather improvement or documentation preparation, 1.3 miles upstream of the terminal, in the LAT position 01°27'.5"S and LONG

056°24'.1"W. c) Anchoring along the Trombetas River is not permitted unless in an emergency, with immediate information to the Santarém River Captaincy and Mineração Rio

do Norte S/A. d) on the Amazon River, in front of the Foz do Rio Trombetas, for waiting ships, when the mooring buoys are occupied. In this case, the anchorage point will be LAT 01°54.5 S / LONG 055°36.0W.

Ships will only be able to enter the Trombetas River after receiving permission from the Port Administration and confirming, on the ship's AIS (automatic identification system), the traffic conditions on the Trombetas River.

Anchorage Area – JURUTI BAUXITE TERMINAL

- Ship awaiting daylight for docking must anchor in the turn basin 1,000 meters upstream of the Terminal. Ship waiting for another, which is loading, should anchor approximately 4 miles downstream of the pier.

Port Authority of Western Amazonia

In the port area of Manaus, it is permitted to anchor vessels in the areas defined as anchorages, considered as 1 (waiting area for docking of general cargo ships), 2 (area for vessels in dispute, including quarantine) and 3 (waiting area for docking and degassing of ships transporting petroleum products), specified in letter no. 4110, with the coordinates as described below:
