International Convention for the unification of certain rules relating to bills of lading, done at Brussels on 25 August 1924

Denunciation by the Republic of Peru - Addendum.

On 19 May 2020, the notification of denunciation of the Republic of Peru relating to the above-mentioned International Act has been deposited with the Federal Public Service (FPS) Foreign Affairs, Foreign Trade and Development Cooperation of Belgium.

On 25 March 2021, the Republic of Peru deposited its instrument of ratification concerning the United Nations Convention on the Carriage of Goods by Sea, 1978, done at Hamburg on 31 March 1978, with the Secretary-General of the United Nations (in accordance with Article 30 of this Convention).

On 14 April 2021, a notification with the purpose to clarify the notification of denunciation of 19 May 2020 of the Republic of Peru relating to the above-mentioned International Act has been deposited with the Federal Public Service (FPS) Foreign Affairs, Foreign Trade and Development Cooperation of Belgium.

Taking into account Article 31 of the United Nations Convention on the Carriage of Goods by Sea, 1978, done at Hamburg on 31 March 1978, the denunciation of the above-mentioned International Act is to take effect as from the date when the United Nations Convention enters into force in respect of the Republic of Peru.

The denunciation of the above-mentioned International Act by the Republic of Peru will therefore take effect on 1 April 2022, and not on 19 May 2021, as previously communicated.

UNITED NATIONS CONVENTION ON THE CARRIAGE OF GOODS BY SEA, 1978 HAMBURG, 31 MARCH 1978

PERU: ACCESSION

The Secretary-General of the United Nations, acting in his capacity as depositary, communicates the following:

The above action was effected on 25 March 2021.

The Convention shall enter into force for Peru on 1 April 2022 in accordance with its article 30 (2) which reads as follows:

"For each State which becomes a Contracting State to this Convention after the date of the deposit of the 20th instrument of ratification, acceptance, approval or accession, this Convention enters into force on the first day of the month following the expiration of one year after the deposit of the appropriate instrument on behalf of that State."
